

NYSSHA 2017 TRAIL RIDING PROGRAM

Any nominations sent in after June 1st you will only be able to accumulate hours from the time it was received. Nominations MUST be RECEIVED or POSTMARKED by 8/6/17 to nominate for 2017

The purpose of the Trail Riding Program is to recognize NYSSHA members who enjoy their horse for trail riding and driving on the road. This is a pleasure program, Anyone being compensated for training a horse may not log hours with that Horse/Pony/Mini. Annually, a year End Champion and Reserve Champion award will be presented in the following age groups for the hours of trail riding logged for that year. The age will be determined as of January 1st of the qualifying year

- 1) 17 & Under 2) 18 – 38 3) 39 & Over

RULES

1. YOU MUST BE A RESIDENT OF NEW YORK STATE OR A BORDERING STATE. All riders or drivers must be a member of NYSSHA to participate. Hours will be calculated from November 1st until October 31st of the qualifying year. As soon as the nomination sheets are distributed you MUST send in your nomination form but you may start logging November 1st of the qualifying year. If you ride more than one horse, keep records on both horses and the total figure will count for both trail riding and driving.
2. Hours will be logged on the honor system. ONLY trail riding and driving hours will count. Ring riding and driving does NOT count. NYSSHA log sheets should be used. Anyone being compensated for training a Horse/Pony/Mini may not log hours with that Horse/Pony/Mini.
3. It is the responsibility of the participant to complete the log form completely, legibly, and accurately.
4. Log sheets must be postmarked no later than November 5th of the qualifying year of trail riding and driving. Mail sheets to: Kim Zelvian, 438 Bridge Road, Berne, NY 12023
